<p>Hired to teach in the approved vocational program</p> <p>4000 hours of occupational experience in the field</p> <p>Recognized competency exam or an appropriate license for day trades and health occupations (contact Greg Belcher 620-235-4637 or Brian Sandford 620-235-4972)</p> <p>Written plan to qualify for full certification during the 4 years of the restricted certificate</p> <p>Vocational orientation or the New Teacher Workshop (TTED 193)</p> <p>Local education agency must assign a mentor</p>	<p>Successful completion of a training program of not less than 18 semester credit hours or the equivalent professional development points (see training program requirements below)</p> <p>4 years of teaching experience in an approved vocational program</p> <p>4 or more professional conferences related to content area within the previous 4 years immediately prior to application</p>
<p>During the 4 years of the restricted certificate, must complete a training program and attend 4 conferences</p>

7. Development of effective teaching methods (TTED 479 or 779)
8. Utilization of technology (TTED 695)
9. Utilization of authentic assessment techniques (TTED 391 or 893)
