- I. PLC Updates
 - a. Facilities Master Planning; work behind schedule all across campus including Axe Library and Block 22; water issue in Bicknell to be addressed; Car Charging stations at KTC not being utilized – questioning the need for spaces at Kelce
 - i. Discussed keeping these car charging spaces in the plan for the Kelce renovation to help ensure progress toward LEED certification.
 - b. rpk Group proposal received; to address organizational structure and market opportunities
 - c. New catalog; web version now up and PDF version within a month or so – let Melinda know of any issues and needed corrections
 - i. Discussion followed among KLT about the inaccuracies and inconsistencies found in the new web version of the catalog.
 - d. Degree Audit System; under development with new look and new functionalities including a “road map” to degree capability
 - e. Leadership PSU – need to submit nominees for this year’s PSU class – discussed names of potential nominees to submit to Provost’s Office
 - f. Gorilla Gateway Course – Provost accepted deans’ recommendation to waive for those students with Freshman Experience Credit; still considering options for transfer students

 - b. Reaffirm AACSB Faculty Qualification targets (handout)
 - i. Policy requires us to re-set the targets since it’s the beginning of the accreditation cycle.
 - ii. KLT voted unanimously to reaffirm using the current targets in lieu of not knowing what might be coming this fall from AACSB. Option to reopen when new standards are known.
 - c. Review draft of “Terminal Degree Requirements” for *Unclassified Personnel Handbook* (handout)
 - i. Needed to update to reflect current organizational structure for the college per request from the Provost’s Office.
 - d. Review results from Spring student evaluation of courses (handouts)
 - i. Reviewed and discussed aggregate results from student course evaluations from spring 2019.
