New knowledge: Research spotlight

Wondering about the effect of a football national championship? So did Drs. Fang Lin and Paul Grimes. Using 33 years of data, they explored how Pitt State's performance on the football field can affect undergraduate enrollment. They found that winning more football games is positively correlated with the overall undergraduate enrollment, primarily through improving retention and enrollment of transfer students. Winning a national title also affected enrollment of first-year students.

CIS in the real-world

Aspiring app developers in a new Computer Information Systems class in the Kelce College of Business have embarked on a real-world project that will help the PSU Nature Reach program.

The class, "Building Web Apps With JavaScript," was created by instructor John Kuefler. "I wanted our



students to have a real-world experience in creating something practical for a client instead of doing a mock assignment like a to-do list app," he said.

Students were thrilled. "It's really awesome to get from a class something that will be used in a real, production environment," said Tyler Webb, a senior in Computer Information Systems.

Their task: to create an app that will track the care given to the raptors being cared for at the PSU Nature Reserve under the direction of Delia Lister. There, a team of student employees feed the Harris hawk, owls, vulture, and kestrel a daily diet of mice, rats, and other small animals, and give them individualized medicines, but until now have relied on recording data on paper in a three-ring binder.

The students began their project by touring the Nature Reserve.

Kuefler sees the class and such assignments as paving the way for preparing more students for a career field that is growing by leaps and bounds.

MBA Association

MBA student and graduate assistant, Jack Thompson, led a group of students in reviving the MBA Association. Advised by Dr. Bienvenido Cortes, the MBAA is a student-led organization that benefits MBA students and the community. Roughly 20 students have committed to help rebuild this organization.

Learning Community

The Kelce College of Business Learning Community (LC) is celebrating its third year. Learning communities have been demonstrated to improve long-term student outcomes. A twosemester sequence of courses, the Kelce LC provides students with the opportunity to develop relationships with fellow students and with faculty earlier in their college careers.

Each fall, first year students are enrolled in one of three Gorilla Gateway sections (an intro to Pitt State class) taught by Drs. Gail Yarick, Alex Binder, and Lynn Murray. Loosely grouped by major in the Gorilla Gateway course, students learn the

required materials with a focus on Kelce and business disciplines. These sections are then brought together in Introduction to Business, a section devoted to them and taught by Prof Mary Wachter. She brings in guest speakers to expose students to the various business careers. In the second semester, students are enrolled either in an accounting course taught by Dr. Yarick or in an economics course taught by Dr. Binder.
