# Kelce Business and Economic Research Center

Dr. Michael Davidsson

Assistant Professor in Economics at the PSU Kelce College of Business continues to be awarded funding from the City of Pittsburg to conduct research regarding financial prosperity in the area and publish the Pittsburg Micropolitan Area Economic Report, a quarterly publication he created in 2013 to provide economic and financial statistics regarding a variety of topics.

Because his specialty is urban and regional economics, Dr. Davidsson is heavily involved in the financial prosperity of the area including collaborating on numerous projects for the City of Pittsburg and Pittsburg Area Chamber of Commerce as well as composing quarterly cost of living surveys for the Pittsburg area. Dr. Davidsson also serves as the media contact and PSU expert on the local economy for the Kelce College of Business.

One such project that propelled major change and has produced tremendous success is a housing study Davidsson conducted for Pittsburg in 2016. Dr. Davidsson's research provided concrete data validating that there was indeed a problem with housing, an issue that was previously suspected but until this point unverified. In fact, his findings revealed that almost half of people working in Pittsburg for major employers commute due to inadequate housing options. This in turn led to a shift in priorities for the city; a housing director was hired, incentive programs developed, efforts to attract residential housing developers made and a marketing campaign targeting these developers created.

"We're interested in making what I would call evidence-based decisions related to policy, and we really would get as much information as we can, objective information," said Jay Byers, assistant city manager. "The work (Davidsson's) done has contributed directly to policy decisions that we're making at the local level, and we're talking about substantial amounts of money here, we're talking about tens of millions of dollars of investment in the community."

Blake Benson, president of the Pittsburg Area Chamber of Commerce, says the work Dr. Davidsson does has been instrumental in procuring and interpreting data that will further advance local businesses and the city itself.

"He's been an incredible addition to our efforts. Data and research are so important to businesses' decisions, and before Dr. Davidsson arrived we knew that data was out there but no one really knew where to find it," Benson said. "He not only knows where the data is located, he's also able to capture it in a format that's very easy to understand, and that's as important as the data itself, so he's been a huge help to us as we prepare data for economic development."

Two studies conducted in the U.S., one in 2015 and one in 2016, cited information from "Growth and Volatility of Micropolitan Statistical Areas in the U.S.," a journal article written by Davidsson, Cortes and PSU economics, finance & banking instructor Michael McKinnis.

Davidsson, Cortes and McKinnis also collaborated three years earlier on the study "Industrial Composition, Local Fiscal Policy and Micropolitan Area Economic Growth" which was later cited in the 2016 article "Metropolitan Spillover Effects and Economic Growth of Non-Metropolitan Areas: Evidence from Indiana Counties" by Litao Zhong published in the International Journal of Regional Development.

Davidsson's extensive and influential research has earned him several honors and awards. Davidsson, primary author, and Cotes also collaborated in 2017 on a study "The Role of the Housing Supply and the Regulatory Environment in Economic Growth of Micropolitan Statistical Areas" and found that flexible housing markets are a necessary condition for economic growth in cities, but not sufficient condition. Each year since 2014, he has been the recipient of the Youngman Research Grant offered through the Kelce College of Business that aided him in various studies and developing local economic Kelce Business and Economic Research Center Dr. Michael Davidson reports he has also been recognized by the PSU Graduate School and Kelce College of Business multiple times, including being featured three times. Over the course of the past three years, he has received \$100,000 in grants from outside sources.

Under the leadership of Paul Grimes, Dean of the Kelce College of Business, Davidsson has recently introduced another research resource to campus: the Kelce Business and Economic Research Center. The center conducts impact studies on the local economy and other projects for a fee and is participating in an Economic Impact Study for Parson's Industrial Park.

A native of Iceland, Davidsson came to the United States in 1985 as part of a Fulbright Institution Program at Lewis and Clark College in Portland, Oregon. Dr. Davidsson received a PhD in Economics from Oklahoma State University in 2012 and in 2013, he moved to Pittsburg, Kansas where he currently works as an assistant professor of economics, finance & banking at Pittsburg State University and serves as an economic authority for both the university and the City of Pittsburg. He is also the Director of the Business and Economic Research Center for Kelce College of Business.
