PITTSBURG STATE UNIVERSITY Department of Psychology and Counseling **GRADUATE ADMISSION PROCESS**

Individuals who wish to pursue a graduate degree in the Department of Psychology and Counseling are required to be admitted to graduate study in the **Department** and to the **Office of Graduate Studies**. All admission requirements must be completed prior to enrollment in courses in a graduate program. <u>All</u> application materials must be received by the department before applications will be considered. The application deadline for Summer or Fall Semesters is **March 1** and for Spring Semester is **October 1**. One can matriculate into the programs at three different times: Fall, Spring, or Summer. However, applications for the M.S. Clinical Psychology program will be considered for Fall Admission Only. Late application deadlines are May 1 for Summer or Fall admission and November 15 for Spring admission. Late applications will only be considered if space is still available in the program. A non-refundable late application fee of \$25.00 payable to Department of Psychology and Counseling is required.

- Department Application and Non-Refundable Application Fee of \$40.00 (this is in addition to the Graduate Studies application fee) payable to Department of Psychology and Counseling:
 - Once the student has been accepted, additional fees are required to cover the cost of criminal background checks. The student's acceptance status will be considered "conditional" until the fees have been paid and the criminal background check has been completed.

Costs:

- $\overline{\circ}$ Domestic students with one last name no additional fees.
- Domestic students who have more than one last name (maiden name, married names, nicknames or other names used) -\$18.00 per last name.
- International students must pay the actual cost of the criminal background check for the student's specific country.
- PSU Disclosure and Authorization Form (Consent for Release of Criminal Background Check)
- Personal Statement of Career Goals (describing your background, professional/educational goals, and specific program area of interest at PSU)
- Official Graduate Record Examination (GRE) Scores (General Test Only) GRE is not required for students with an undergraduate GPA of 3.3 or above. GRE is required for all students with an undergraduate GPA of below 3.3 a minimum score of 146 on the Verbal Reasoning area, a minimum score of 141 on the Quantitative Reasoning area, and 3.5 or above on the Analytical Writing area PSU Institutional Code: R6336 Department Code: 2005
- Three Completed Professional Recommendation Forms (At least one reference should be from a teacher or academic advisor who can speak on behalf of your academic performance. References from friends, relatives, neighbors, ministers, personal physicians, and personal counselors are not acceptable. References from employers, teachers, or academic advisors are preferred.)
- Overall Undergraduate GPA of 3.0

Criteria for Admission

The Department Admissions Committee will review applications after each application deadline and recommend acceptance or rejection of applicants, based upon applicant qualifications and program capacity. Minimum requirements for admission include an overall undergraduate GPA of 3.0, a minimum score of 146 on the Verbal Reasoning area, a minimum score of 141 on the Quantitative Reasoning area, and 3.5 or above on the Analytical Writing area on the GRE, favorable recommendations, and a personal statement that aligns with program goals. (Applicants not meeting the minimum standards may be considered for admission when program capacities permit.) In all cases, a minimum TOEFL score of 550/79 for students whose primary language is not English is required for admission.

Department Policy on Criminal Activity

Most graduate students in the Department are at some point involved in providing direct mental health services as part of their practicum and internship experiences. As a result, the Department has a policy that requires *all* applicants consent to background checks with Validity Screening Solutions regarding the applicants' history of convictions for crimes involving violence or exploitation of others. Failure to sign the PSU Disclosure and Authorization form will result in the immediate denial of the application. The application fee helps to recover the costs of obtaining this information.

Notification of Applicants

Applications that are complete by the deadlines will be reviewed by a committee and will receive a letter informing them of the department's recommendation or rejection. Those admitted to the program will receive an official letter of admission from Graduate Studies following the department notification.
