My primary goal today (besides, thank you for being you...happy holidays...and a little update) is that you read and approve/comment on the attached November meeting minutes. - 1. I had already updated the Senate that I had met with Diane Letner, and we had discussed having a joint USS/UPS Satisfaction Survey Subcommittee to review the common responses we would like to address, and how we might address them. This would include creative resolutions we could present at our open "townhall-like" meeting we'll have later in the spring 2023 semester. Would any of you like to serve on this subcommittee? If not, I will ask at our next general UPS meeting for volunteers.
- 2. After we last met, I reached out to Lindell Haverstic about the email list for the Satisfaction Survey in 2019. There was a discussion last meeting about a faculty member who wanted to know if he was a UPS employee and what was the difference between UPS and Faculty. This led to some research, and I asked for a complete list of all UPS employees from Rachel. She provided this, and there are many, many faculty and administrative UPS employees on this list who would not qualify to be a UPS Senator, or who should be taking this survey. In my discussion with Lindell, we identified those who should not complete the survey or who could not serve as a Senator as follows:

## UPS employees who CAN NOT serve on UPS (as defined in the Bylaws):

Members of the University Leadership Team (name needs Bylaws update)

Members of the Provost Academic Affairs Leadership Council (name needs Bylaws update)

Members of Faculty Senate

UPS employees who SHOULD NOT serve on UPS (not defined in the Bylaws - let's discuss sometime):

UPS hourly employees (recently hired, previously USS employees so should serve on USS Senate)

UPS employees (including Faculty) who CAN serve on UPS (not addressed in Bylaws, thus confusion):

Department Chairs (not included above)

UPS benefits-earning employees
