- Associate's Degree legislators were complimentary of this move

 - o forensic science lab
 - o would be located in Tyler Research Center
- Working to put together soccer pitch for September games
 - o approximately 38 committed; about 10 already here this spring
- Professional Development challenges
 - o LinkedIn platform is now being finalized
 - online courses and modules will be available to all
 - o Looking at in-person learning opportunities for connecting with others
