- d. Dr. Scott is optimistic about the proposed \$45.7 million budget for the KBOR system

- e. Dr. Scott is encouraged about the Deferred Maintenance funds for the University
- f. Dr. Scott said that there may be funding for cyber-security.
- g. He expresses hope and is cautiously optimistic.
- h. There will be a second town hall in April, when the budget process looks a little clearer

 - 2. Dr. Naccarato reported that one chamber of the Kansas legislature has passed a \$45.7 budget for KBOR schools. Status of the bill still unknown in the Kansas Senate. So not final yet
 - 3. \$35 million for deferred maintenance, proposed
 - 4. \$20 million for demolition of some campus buildings
 - 5. Dr. Smith reports top things for retention are advising, data utilization, and student information system.
 - 6. As of November 20, PSU dropped the application fee
 - 7. As of March 1 PSU was up 395 applications
 - 8. PSU up 353 admissions
 - 9. 487 CARES Apps, up 17 by headcount
 - 10. Housing apps down 33 by headcount
 - 11. A 5% proposed raise for employees, if passed, would be \$2.5 million for the University to pay out of the budget
