Dr. Humphrey shared that they are requesting to create this certificate and courses as part of a cooperative agreement with KU. Students will complete their first year of a Master of Social Work program at PSU and then transition to KU to complete the program. She shared that having students pursue the program through a certificate program at PSU would allow students the option to obtain financial aid.

Dr. Humphrey was asked if the courses were all new courses, she explained that the new courses are cross listed with senior social work courses and that these courses will have an additional requirement since they are master level courses.

Dr. Jayawardhana asked it the degree would be obtained from KU. Dr. Humphrey explained that the students would earn the Master of Social Work degree from KU and a certificate from PSU.

MS Psychology (Behavior Analysis) Request for Degree Changes

Courses to be added to candidacy: PSYCH 841 Basic Behavior Analysis,

Courses to be deleted from candidacy: PSYCH 849 Verbal Behavior, PSYCH 851 Complex Behavior, PSYCH 722 Fundamental of Tests and Measurement, PSYCH 891 Methods of Research in Psychology and Counseling

Dr. Speelman explained that the requested changes are a housekeeping matter. They are deleting courses that are not being taught due to staffing and some that are not part of the program.

Request for Creation of Course PSYCH 841 Basic Behavior Analysis Dr. Speelman shared that PSYCH 841 is being created because many students take PSYCH 741 as undergraduates and if PSYCH 741 is not part of the students graduate transcript it will not be recognized for certification.

Dr. Jayawardhana asked if students take PSYCH 741 in their final year do they need to take PSYCH 841. Dr. Speelman said that these students would need to take PSYCH 841.

Request for Creation of Course PSYCH 892 Special Research Project

Dr. Speelman shared that PSYCH 892 will be offered to students completing a capstone project instead of a thesis.

Certificate in Behavior Analysis Request for Degree Changes

Courses to be added to candidacy: PSYCH 841 Basic Behavior Analysis, PSYCH 830 Psychology of Learning, PSYCH 861 Internship in Behavior Analysis

Dr. Speelman explained that the changes to the certificate are to keep up with certification standards so that students can be certified and licensed.

Dr. Brannock moved to approve the Psychology and Counseling curricular matters, Dr. Harris seconded and the motion carried.

2021 Research Colloquium

Dr. Sims shared the following regarding the Research Colloquium:

- He emailed a link to the Research Colloquium webpage to the council prior to the meeting.
- The categories have been narrowed.
- Students will do virtual 3-5 minute presentations with a poster or a power point.
- Studio will be used to create videos and the videos will be uploaded to Canvas.
- Abstracts are due March 10<sup>th</sup>.
- Presentations are designed to be done by one person.
- Requesting volunteers for judging. Judging will be done virtually.
- Winners will be posted to the website.
- An abstract book will be created.

Dr. Thompson asked if students would need to be available for questions as they have in the past. Dr. Sims said that students would not have to be available for questions.

Dr. Santra asked if there was a plan to give awards at a banquet. Dr. Smith explained that there may be a virtual awards ceremony. That awards would be given to students or possibly given to faculty to provide to students.

Information Item:

The departments shall elect a representative to the Graduate Council prior to March 1 of the academic year. The term for the representatives to the Graduate Council shall be from August 1 to July 31 of the subsequent year. Each department chair shall notify the Dean of the Graduate School by March 15 of their elected members. The newly elected representatives shall meet in April for the sole purpose of electing the officers as indicating in II. B. and the Executive Committee as outlined in I. C. 6. the forthcoming year.
