Dr. Kuehn moved to make these a unit. Dr. Winters seconded and the motion carried.

Dr. Willard moved to approve the Graduate Service Recommendations, but noted that a couple of the forms did not have the explanation of qualifications that was determined to be necessary at the last meeting. Dr. Fogliasso seconded and the motion carried.

College of Education:

Curriculum and Instruction:

New Degree: (Effective Summer 2007) Master of Arts with a major in Teaching

Dr. Taylor and Dr. Sparks were present to discuss the Curriculum and Instruction matters. Dr. Sparks explained the new MAT degree will meet a need for teachers and for areas that have a shortage of teachers, by allowing individuals that have a Bachelors degree in disciplines outside of teaching to earn a Masters degree in teaching. Students entering this degree program are required to have a Bachelors degree, meet the admission requirements, and have already been offered a teaching position. Dr. Taylor explained the alternative licensure program is simply not appropriate as part of the current Master of Science degrees offered since a Bachelors degree in Education is not required. The MAT will provide instruction on methods of teaching to students that already have content expertise through their Bachelors degree. She added the program is currently in its sixth 2-year cohort, which points to the success and demand for such a program. Dr. Daley inquired as to whether such students would then have an emphasis in their area of expertise. Dr. Snyder stated they will not. Their undergraduate degree provided the area content, the MAT will provide the pedagogy. Dr. Daley then inquired whether these students would be required to take a content-based exam at the Masters level. Dr. Sparks stated this is covered in the licensure test for the State of Kansas. If a student becomes licensed, we assume they are gualified. Dr. Jones inquired whether individuals with an undergraduate music degree could pursue this degree. Dr. Sparks responded they could, as long as they meet the admission requirements. Dr. Willard added that the KSDE and the Regents invited the College of Education to have an MAT degree.

Dr. Kuehn motioned for approval, Dr. Winters seconded and the motion carried.

Dr. Taylor explained this course will align with the MAT curriculum and meet student need.

Dr. Oppliger was present to discuss the matters. Dr. Snyder first inquired as to what options the department would want available to students in the new catalog. Dr. Oppliger responded that options I and III (Thesis and Course Work) are the options they want to offer. He then went on to explain the agenda matters were developed to provide more specific programs for students to pursue. Dr. Ward inquired as to whether they are moving away from including education, since their titles no longer include the term. Dr. Oppliger responded that education will remain part of the programs; the name changes are more about keeping up with trends and growth in the area. PSU is the next to last school in the regents to make these changes; many other departments use human performance and various other titles to explain their programs. He added the new titles and emphases give more options to students, who might want a more specific program of study or one that is more general.

Dr. Willard motioned to make these items a package (including the changes in options) and for approval, Dr. Bauchmoyer seconded and the motion carried.
