Request for Creation of Course: (Effective Spring 2007) SSLS*870 Grant Writing and External Resources

Dr. Frieden explained this course is being created to bridge the gap between theory and research. Dr. Snyder stated this course has been taught as a Topics course for several years.

Dr. Willard moved for approval, Dr. Allan seconded and the motion carried.

Old Business:

Proposed Amendments to the In Progress Grade Policy – Dr. Snyder

Dr. Snyder explained the first paragraph has already been approved in November by this Council and has also been approved by the Faculty Senate. If any changes are made in the future to this content, the Faculty Senate will also need to approve the change in order to maintain one policy for this grade in the catalog. Dr. Snyder informed the Council that, if the one year deadline amendment is approved, any faculty member can request an extension for that course for another year. This request must be made to the Registrar and requires the signatures of both the advisor and the Chair. Dr. Snyder went on to explain the possible amendments. Dr. Jones stated the first amendment (Concerning Legislation) takes care of any initial concerns the Council may have had.

Dr. Jones moved for approval of the Legislation amendment,

Dr. Willard seconded and the motion carried. Dr. Roush abstained.

In discussing the amendments regarding Time Limits, Dr. Roberts stated their particular course that would carry this grade can take longer than one year to complete and should not be changed

to an F. Because of that, the second option would be most useful to their department. Dr. Snyder explained it is a departmental choice to be excluded from the one-year roll or not. If a department chooses to be excluded, they must legislate both the course to use the IP grade as well as exemption from the one-year rule. Dr. Jones inquired about the advisors ability to give a grade of F if the course is an IP course. Dr. Snyder responded that an F can be given whenever an advisor sees fit.

Dr. Schwindt moved for approval of the second Time Limits amendment, Dr. Allan seconded and the motion carried. Dr. Roush abstained.

New Business:

Course Grade Requirements and Academic Standing – Dr. Snyder

Dr. Snyder explained that she is bringing this before the Council because it is not clear it if has even been approved by them prior to this date. She explained that for any student who receives a grade of C and does not receive a grade of A to offset the C (i.e. has earned less than a 3.0 GPA), she currently contacts the department to give them a choice of whether the student should be placed on academic alert or academic dismissal. The issue becomes more serious when a student has earned grades of D or F during two semesters. Dr. Willard inquired as to the policy for students to retake a course. Dr. Snyder responded that this policy is in the catalog. If a student earns a grade of C or lower, they may retake the course one time. The Council offered suggestions on the wording for the policy and it will be brought back to vote on during the March meeting.

Discussion:

Thesis – Approval page beyond the approval page included in the thesis

Dr. Snyder explained that some departments have mentioned there should be an additional approval page (beyond that page that is included in the final thesis for binding) to document the Thesis Committee's approval of the student's thesis. The Council was instructed to think over this topic for discussion at the next meeting.

IELTS:

Dr. Snyder added this topic to the agenda. She explained that students expecting to study in other countries (i.e. Great Britain, Australia, New Zealand...) are required to take the International English Language Testing System (IELTS). If they then decide to come to PSU, they are required to take the TOEFL, which creates difficulties for some students. Several important universities in the U.S. currently accept either the TOEFL or the IELTS. Dr. Snyder requested discussion on whether the Council thought this would be acceptable at PSU. Dr. Willard questioned whether this test has been validated in comparison to TOEFL scores. Dr. Snyder responded they have. Dr. Jones asked if this would simply be another option for students or would take the place of the TOEFL. Dr. Snyder stated it would be another option. She informed the Council that she will come back with more documentation and information at a later meeting.

Dr. Bauchmoyer moved to adjourn, Dr. Box seconded and the motion carried.

In Progress Grade as approved by the Graduate Council, November 8, 2006

IP In Progress, zero credit given, zero grade points per semester hour. Temporarily recorded as a grade when a student is enrolled in a course that requires the student to engage in projects that extend past the end of the semester. The "IP" signifies that the faculty member acknowledges the student is enrolled in a long term project and that the project is not yet complete. Credit is postponed and the course is not included in the student's Grade point average.

In Progress Grade Amendment as approved by the Graduate Council, February 14, 2007

IP In Progress, zero credit given, zero grade points per semester hour. Temporarily recorded as a grade when a student is enrolled in a course that requires the student to engage in projects that extend past the end of the semester. The "IP" signifies that the faculty member acknowledges the student is enrolled in a long term project and that the project is not yet complete. Credit is postponed and the course is not included in the student's Grade point average. An In Progress course must be satisfactorily completed within one year from the date the IP was given. An In Progress not removed within one year shall be regarded as a failure and the IP grade will be changed to F and included in the computation of the student's GPA.

Courses to be established for the use of the IP grade must be legislated through department/college curriculumn committees and the Faculty Senate/Graduate Council. Courses can be legislated to be excluded from the one-year regulation of changing to F if the course is not completed.
