## GRADUATE COUNCIL MINUTES Wednesday, November 14, 2007

It was requested that Old Business be moved to the first item on the agenda. Dr. Hodson was present to discuss the issue of fundraising for Graduate Assistantships.

Old Business:

Fundraising for Graduate Assistantships – Dr. Hodson

Dr. Hensley opened the conversation by stating that the council needs an idea of the strategy needed to move on this topic. Dr. Hodson stated that the first step is to express an interest, which the council is doing. Next is to identify a niche market and to create a small group that can verbalize to the Development staff what exactly is needed. He stated that the annual giving staff can develop materials specifically for this need. He emphasized that this need can be integrated into existing campaigns, which eliminates the problem of starting from scratch. He also stated that, while there is not a major gifts coordinator for the graduate school, there are major gift coordinators assigned to each of the four colleges, which could help with this goal. Dr. Jones stated that there are serious deficiencies for graduate assistantships and that such assistantships truly do benefit the university. He would like to see this need included on lists of options that are given to potential donors. Dr. Hodson stated that graduate areas are already on the list in a very general scope, but the listing can be made more specific. Dr. Snyder put forward the idea of creating a bio of the typical graduate students we get at PSU to assist donors in grasping an idea of the reality of our programs. This idea was widely accepted. Dr. Jones expressed his belief that creating more assistantships could increase the number of students and the quality of the programs offered. He inquired whether scholarships are usually only geared toward undergraduate students. Dr. Hodson stated that, unless specified, scholarships can also be for graduate students. Dr. Jones stated he feels that publicizing our graduate students' accomplishments across the campus and in the alumni newsletter would also help this cause. Dr. Hensley requested that a group be established that can meet with the Development staff and that Dr. Snyder be in charge of calling the first meeting. Dr. Winters, Dr. Jones and Dr. Hensley volunteered. It was established that other members could also join the group as meetings are established.

Dr. Willard moved to form this committee, Dr. Kuehn seconded and the motion carried.

The minutes of the Wednesday, October 10, 2007 meeting were approved with no corrections.
