Graduate Service approvals for those with masters degree - Dr. Willard

Dr. Willard added this topic to the agenda as a point of discussion. He noted that, over the past few years, several people have been approved for Graduate Service that have only completed a masters degree. He is not opposed to this practice, but thought it should be studied more carefully to determine if this is happening more often than the Council realizes. He feels that people are initially approved for one course and then other courses in subsequent semesters, making them able to teach several courses with only a masters degree. He noted particular concern with this being more prevalent with online courses and wondered if a policy on this topic should be established. Dr. Schwindt inquired what the terminal degree was for the cases that Dr. Willard noticed. Dr. Willard was not sure. Dr. Drew felt the topic is important, but that it is already being monitored through departmental and college approvals, the Graduate Council and program review. Dr. Kuehn noted the importance of distinguishing ourselves from other universities offering online degrees. Dr. Sandford stated he would like to know the guidelines for the graduate programs at PSU (i.e. rigor, enrollment numbers, etc). If our programs are based on rigor, the level we can offer is based on instructor qualifications. Dr. Schiefelbein asked if it can be noted on the Service Request form whether or not the person has the terminal degree for the department. Dr. Willard agreed to write up some thoughts on this issue and bring it back to Council to examine forming a committee.

Fundraising agenda – Dr. Jones
