She will then send the remaining list (from 2001 to the present) to each department for review and allow the

department time to determine if students from the list should be allowed to complete their IN course(s) or if they should also be changed to IX. She will include the new policy pertaining to grades of IN and IX with the list of students for departmental information.

Dr. Jones moved to allow any grades of Incomplete prior to 2001 be changed to a grade of IX for students who are not currently enrolled in a degree program, Dr. Kuehn seconded and the motion carried.
