Old Business:

Allowing changes to students candidacy plans – Dr. Snyder

Dr. Snyder brought this to the Council for approval. She explained that an email will go to students when changes have been made to the candidacy after original approval and that Chairs will be required to re-sign a changed candidacy at the time of graduation.

Submitting midterm grades – Dr. Snyder

Dr. Snyder explained this is still under consideration by Faculty Senate. It will be brought back to the Council when/if the Senate decides to change the current policy.

New Business:

Overload Enrollment Policy - Dr. Snyder

Dr. Snyder stated that the academic Deans have created a form and already have a process in place for approving overload requests. Consideration is being given to placing the form online. If the undergraduate policy is re-written, she would like to consider changing the graduate overload from 15 to 16 hours, to allow for those programs that require a 1-hour intro course.

Clarify New Incomplete Policy – Dr. Snyder

Dr. Snyder issued a reminder that, under the new Incomplete grade policy, advisors can request an extension for one semester only. Continuous extensions are not allowed. Research and thesis courses that did not previously roll to a grade of F and courses that allow In-Progress grades are not a part of this policy.
