Dr. Shirley explained the department is asking to change their current MS degree program from having no emphasis to having three separate emphasis areas. Each emphasis will be distinguished from the others by research only. Dr. Snyder stated that emphasis areas are generally distinguished by 9-12 credit hours in a degree program, which would not be the case with this change.

Dr. Shirley moved to approve these requests as a unit, Dr. Sandford seconded. The motion failed with 3 approving votes and 9 opposing votes.

Dr. Ward explained these changes are requested in order to bring the MS Psychology (General) degree up to compliance.

Dr. Ward moved to make these a unit and for approval, Dr. Kuehn seconded and the motion carried.

Old Business:

Changes to Graduate Assistant Policy – Dr. Snyder

Dr. Snyder gave an fyi that the new policy has been approved by the Provost's Leadership Council and will be in effect for the Fall 2011 semester. This policy lowers required enrollment from 9 to 6 hours, sets the maximum enrollment at 12 hours without approval and defines the overload allowance.

1. New Business:

Two policies pertaining to large/combined departments – Dr. Snyder

Fair representation on the Council – Dr. Snyder explained the current departments of Curriculum and Instruction and Special Services and Leadership Studies graduate more than 50% of students graduating each year. It is possible that these two departments will be combined in 2012. Under the current policy they would have only three representatives. It was discussed that language could be changed to say "degrees" instead of "departments" or a range going beyond 3 representatives could be established. Dr. Snyder will draft options and bring this back to the Council for review.

Outside member on thesis committees – Dr. Michael Kelley was present to discuss how the merging of the previous History Department into the current History, Philosophy and Social Sciences has negatively affected the thesis committees of History majors. A request to review the policy language could be changed to say "degree" instead of "department" in reference to the outside committee member.

Dr. Dresner moved for approval, Dr. Kuehn seconded and the motion carried.

Potential Partnership to provide a graduate program on campus – Dr. Kelley

Dr. Michael Kelley was present to explain that Newman University has asked to come to campus to offer an MS in Social Work. An MS in Social Work is a degree program many PSU undergraduate students have requested, but our department cannot offer themselves. The opportunity will be offered to other Kansas state universities first if determined to be beneficial. The Council decided they would like to review the degree program being offered and continue this discussion at a later meeting.

Nominations and Voting for New Officers for the 2011-2012 Graduate Council

Chair – Dr. Sandford was nominated and accepted. Vice Chair – Dr. Jayawardhana volunteered for the position.

Dr. Samuels moved for approval, Dr. Ward seconded and the motion carried.

Approval to change the next meeting date to the first week of the month instead of the second to allow for a review of Spring graduates.

Dr. Snyder asked Council members to remind their departments that any legislation for May's agenda needs to be submitted a week earlier than usual.

Dr. Williamson moved for approval, Dr. Kuehn seconded and the motion carried.
