CONSTITUTION AND BYLAWS OF THE GRADUATE SCHOOL Of PITTSBURG STATE UNIVERSITY

C. GRADUATE COUNCIL

1.Membership

The Graduate Council shall be composed of one elected member of the Graduate Faculty of each department offering a graduate degree. Those departments with more than 25 graduates in the immediate past year are entitled to a second representative on the Council. Departments are entitled to a third membership on the council for over 50 graduates is the immediate past year or with more than one degree program and over 40 graduates in the immediate past year. The Registrar and Dean of Graduate School shall be ex officio members. The departments shall elect a representative to the Graduate Council prior to March 10f the academic year. The term for the representatives to the Graduate Council shall be from August 1 to July 31 of the subsequent year. Each department chair shall notify the Dean of Graduate Studies and Research by March 15 of their elected members. The newly elected representatives shall meet in April for the sole purpose of electing the officers as indicated in II. B. and the Executive Committee as outlined in I. C. 6. for the forthcoming year.

PROPOSED CHANGE

1.Membership

The Graduate Council shall be composed of faculty from each department offering a graduate degree program. Additional representation from departments is based on the number of students graduating during the previous calendar year. Departments with 25 or more students are entitled to a second representative and a third representative with 50 or more students graduating. Departments are entitled to one additional representative for each degree program with 40 or more students graduating. No department will have more than six representatives on the Council.

The Registrar and Dean of Graduate School shall be ex officio members. The departments shall elect a representative to the Graduate Council prior to March 1of the academic year. The term for the representatives to the Graduate Council shall be from August 1 to July 31 of the subsequent year. Each department chair shall notify the Dean of Graduate Studies and Research by March 15 of their elected members. The newly elected representatives shall meet in April for the sole purpose of electing the officers as indicated in II. B. and the Executive Committee as outlined in I. C. 6. the forthcoming year.
