New Business:

Research Colloquium: April 7, 2016, 8:00-4:30

Dr. Kahol encouraged involvement in the Colloquium and mentioned that the submission deadline is March 11th but that he would open to extending the deadline a week to 10 days.

Graduate Assistant Stipend increase effective 2016 Winter/Fall semester.

Dr. Kahol informed the council that the Graduate Assistant stipend will increase from \$5,000 to \$5,500 effective 2016 Winter/Fall. Departments that currently have higher stipends will remain the same.

Dr. Kahol informed the council that Doctor of Nursing Practice students will have one Option, a "Scholarly Project" to complete as part of their degree requirements instead of the three Options that are part of the masters and Ed.S. programs. This project will be added to the DNP student candidacy plans and a description of the project will be added to the catalog.

May Graduate Council Meeting: Spring graduation is the first week of May, should the May meeting be moved ahead another week to Wednesday, April 27, 2016?

Dr. Flood moved to move the May meeting to April 27th, Dr. Dresner seconded and the motion carried.
