Dr. Kahol described the section of the By-laws regarding Graduate Faculty and Graduate Service Faculty. He explained that sometimes departments would like to have an outside person that is not a PSU faculty member serve on thesis committees. If departments want to have an outside person approved to serve on a thesis committee currently they cannot be approved since they are not PSU faculty. Dr. Kahol suggested creating a third membership category for these individuals and adding it to the By-laws. There was discussion regarding what this category would be named and what credentials would be required of these individuals. Dr. Kahol plans to write up a proposal for this category and include it in the November agenda.

Dr. Sims brought up the issue of academic misconduct. He pointed out that there is an academic misconduct policy in place for undergraduate students but that there is not a policy for graduate students. He expressed the need to create this policy during this school year. Dr. Kahol agreed to develop a policy and to bring it to the Graduate Council for approval.
