Revision of Thesis Guide

It was pointed out that with the addition of Graduate Research Associate Faculty in the by-laws the following would need to be revised in the Article I: Organization section: "I.B.2." will need to be changed to "I.B.3." and section B "Categories of Graduate Faculty" will need to be changed to "Categories of Members Involved in Graduate School Programs."

Dr. Shirley suggested revisions to other existing language in the by-laws.

Dr. Hudiburg moved to approve the language changes with the two revisions listed above, Dr. Roberts seconded and the motion carried. Dr. Shirley opposed.

Dr. Flood asked Dr. Kahol if he could speak to the council regarding the Academic Honesty policy that was previously discussed. Dr. Kahol shared that he previously thought that the University Academic Honesty Policy was passed by Faculty Senate. After checking into the policy he found that it was not passed by the Faculty Senate, that it is a University policy and that there are Graduate Faculty and one graduate student on the committee for this policy. Dr. Kahol mentioned that he had asked for a group to work to put together a policy for graduate students but now feels that there is no need to develop this policy since it is a University policy. Dr. Flood shared that the Faculty Senate has made changes to the wording of this policy. Dr. Kahol is going to consult with the Provost and decide if Graduate School needs to develop their own policy or not.
