Remembering Judy Shaw


#### PSU Mourns the Loss of Judith Shaw

Many members of the PSU family turned out to mourn the passing of Professor Judith 'Judy' Shaw, a much loved scholar and teacher of European History who served as a member of the PSU family for over 50 years. Attending the memorial were former and current colleagues, staff, students and members of the larger Pittsburg community. Provost and Vice President for Academic Affairs Dr. Lynette Olson and Dr. Kelly Woestman of the Department of History, Philosophy and Social Sciences recounted memories and Dr. Susan Marchant and Stephen Gedert performed a moving instrumental

piece. Michael Shaw gave a testimonial of Professor Shaw's eagerness to return to work at Pittsburg State prior to her passing on December 25th, 2012. Professor Shaw was a founding member of PSU-KNEA and remained active in the organization for many years. She will be greatly missed.

#### Bargaining Rights, Part 1

"We take seriously our obligation to negotiate."



The recent decision by the Kansas Board of Regents to institute a posttenure review process at all Kansas Regents institutions represents a significant departure from existing procedure and requires the attention and active participation of all Unit faculty. To begin the process, on November 26th, 2012, PSU-KNEA President Ananda Jayawardhana issued the following statement at faculty senate:

"PSU-KNEA is the recognized authority at Pittsburg State for the purposes of meet and confer. We take seriously our obligation to nego-

tiate on behalf of the unit on all matters pertaining to faculty working conditions, including those that relate to academic freedom issue. Please forward all and tenure, due process and university citizenship. It is our position that policies that effectively revise the contract in the absence of fulfilling the obligation to meet and confer are non-contractual and cannot be enforced. The PSU/KNEA Executive Committee is not supportive of the proposed Post-Tenure Review. PSU/ KNEA will conduct a survey of Unit members before the negotiations in 2014 and negotiate accordingly."



### **Bargaining Rights, Part 2**

On August 28th, PSU-KNEA President Ananda Jaywardhana submitted a letter requesting the right to negotiate the matter of tobacco use on campus to PSU President Dr. Steven Scott. Serif Uran (Physics) has been appointed to the President's Tobacco Control Task Force as the representative of PSU-KNEA and will be providing an update at the general meeting on March 26th.

The PSU-KNEA Execu-

tive Committee is not supportive of exclusionary policies and continues to follow the issue.
